### LOCATION SELECTION

All vendor locations have limited availability. Space will be assigned on a first-approved, first-paid basis and electrical requirements.

### BEVERAGE POLICY

Vendors **may not sell any beverages from their booth at Beach Blast Off 2010 at any time.** We have sponsors for the event.

### CHILI VENDOR REQUIREMENTS:

Each Chili Vendor will be required to supply at least 20 gallons minimum of chili to serve in 2oz. samples to patrons. Chili can be white or red based with beans or no beans. Chili Vendors must be set-up no later than 3:15 p.m. Judging will start at 5:00 p.m. ***Chili Vendors are encouraged to sell "Chili to Go" sizes after Winners are announced at 7:00 p.m. with tickets only.***

*One table and 2oz. sample taste cups will be provided to each vendor. Each vendor may decorate or advertise their table.*

Chili Vendor must provide own various paper products, heat source, electrical cords and other items that will provide safe and sanitary food service.

### TICKET SALES & REIMBURSEMENT

Taste tickets will be sold to our attendees for a price of \$1.00 per ticket. One ticket per 2oz. sample served. **Chili Vendors will not accept cash for chili samples (Tickets Only).** Chili vendors will be allowed to sell novelty items with their restaurant logo such as t-shirts, sauces, etc. at their table.

Each vendor must collect tickets and submit them at the end of the event to the Chili Coordinator for accounting. Tickets collected will be counted within **7 days** of the event. The Beach Blast Off 2010 Committee will reimburse **50%** of the total submitted ticket revenue by check within 14 business days following the event.

### CANCELLATION

If Vendor cancels participation within **14 days** of the event or does not show up the day of the event for any reason their entry fee will be forfeited to cover any costs for advertising, tables, supplies, etc.
